

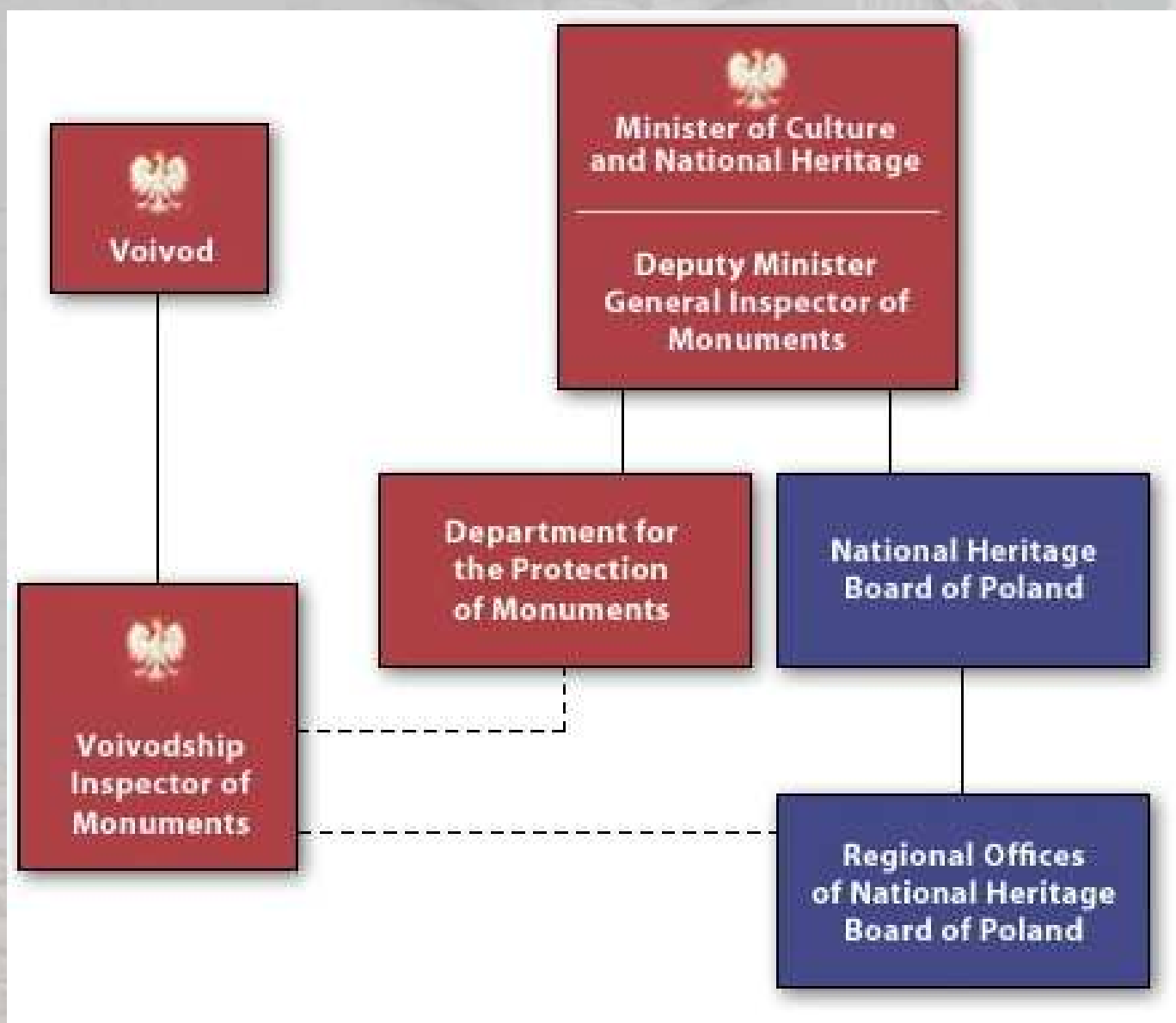

The justification of creating the new National Heritage Board of Poland

Genesis:

The necessity of implementing homogeneous policy of the State within the sphere of protection, management and guardianship of cultural heritage

The regulations of the Board's statute aim at:

- ✓ **creating the frameworks** of cooperation between the Board and heritage protection services
- ✓ working out coherent principles of **heritage protection doctrine**, which would meet modern challenges
- ✓ providing **more efficient control** over processes taking place in cultural environment
- ✓ elaborating and **implementing homogeneous system** of cultural heritage protection and documentation
- ✓ creating applicable conditions for the civil society development by the means of **ruling the cultural identity** of citizens and **supporting various initiatives** connected with heritage protection

Aims of the National Heritage Board of Poland

- 1)) **elaborating the principles of heritage protection doctrine** within the range of cultural heritage and monuments protection
- 2) working out and implementing homogeneous **system of cultural heritage protection and documentation**
- 3) introducing and popularising **new methodological standards** of research, record and conservation of monuments



- 4) collecting copies of decisions, issued by the Voivodship Inspectors of Monuments, on listing particular objects into the Register of Monuments
- 5) conducting the National Monuments Record
- 6) keeping the record of archaeological research

Aims of the National Heritage Board of Poland

- 7) carrying out **archaeological rescue research** on sites threatened with serious damage
- 8) carrying out **research works on monuments** threatened with serious damage
- 9) **supporting the supervisions** of Voivodship Inspectors of Monuments over undertaken archaeological works
- 10) **monitoring the state of preservation of cultural heritage** as well as estimating endangered monuments





Aims of the National Heritage Board of Poland

- 11) collecting and **sharing the information** on museums
- 12)) coordinating and participating in works on periodical reports on Polish sites and objects placed in **UNESCO World Heritage List**
- 13) coordinating procedures of submitting applications to the Minister for nominating particular sites and objects as the **Monuments of History**, authenticated by the President of Poland



Aims of the National Heritage Board of Poland

14) conducting **training and informative programs** in support of heritage protection services as well as institutions and individuals engaged in the protection of monuments

15) **popularising the knowledge** of cultural heritage and undertaking educational activities connected with the protection of monuments





Aims of the National Heritage Board of Poland

16) **giving opinions and expertise** in support of General Inspector of Monuments and Voivodship Offices for the Protection of Monuments

17) **organising and carrying out other works** connected with the protection of cultural heritage on commission of the Minister and General Inspector of Monuments

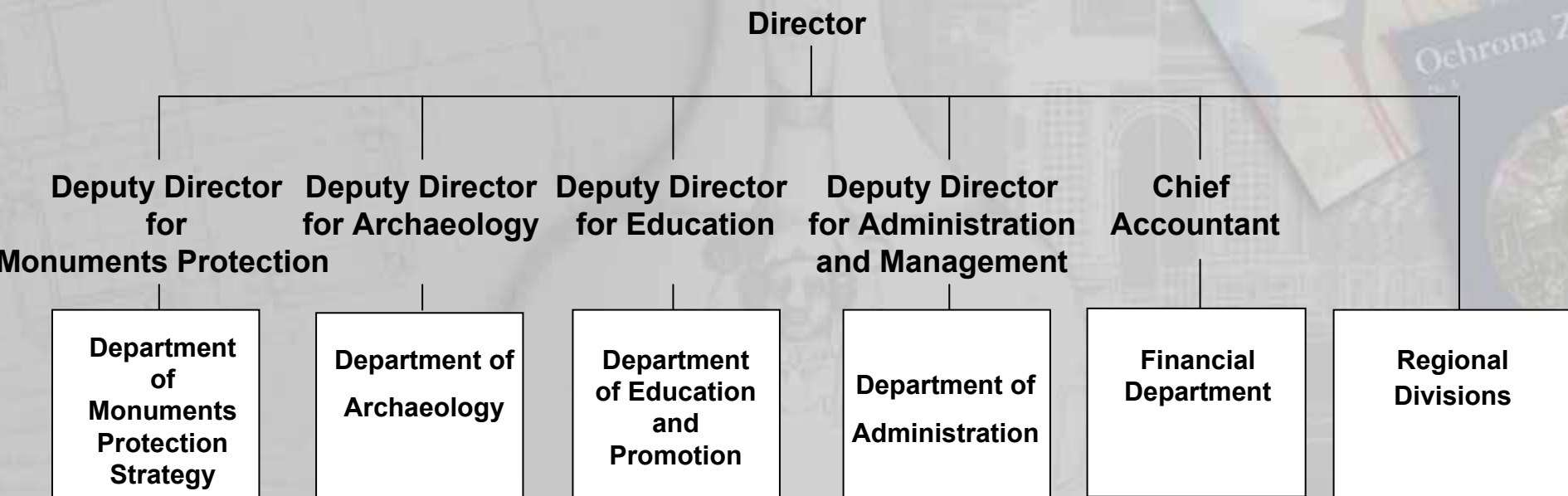

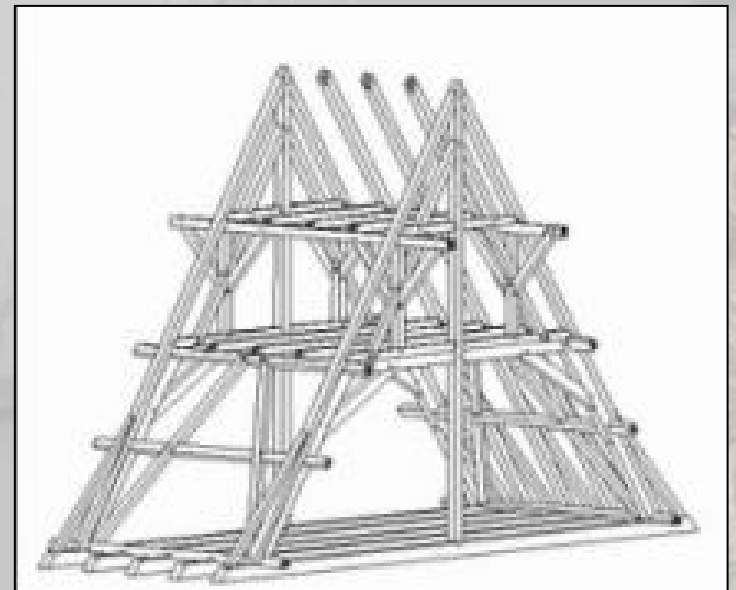
Section for Heritage Protection Policy

- ✓ creating and implementing **standards of heritage protection methodology**
- ✓ **preparing opinions**, expertise and analyses in the field of monuments protection
- ✓ **monitoring**, analyzing and evaluating present heritage protection activities within particular theme spheres



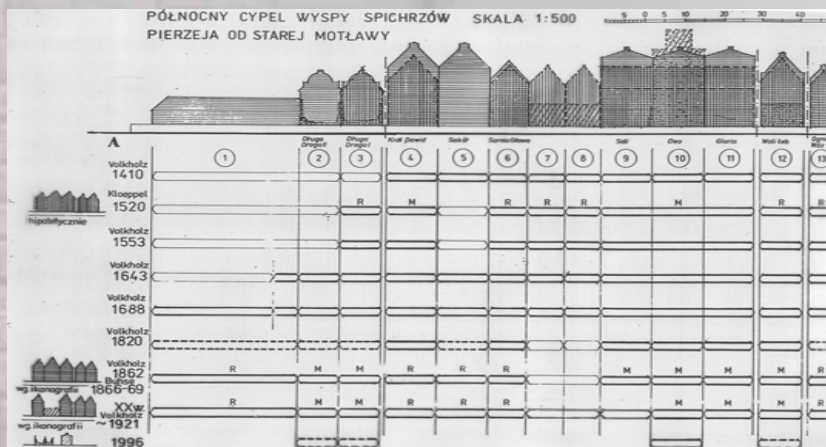
Section for Monuments Research

- ✓ **carrying out research**, preparing opinions and expertise as well as heritage protection proposals and principles within the sphere of monument protection
- ✓ **elaborating heritage protection issues** on the protection of cultural values in construction projects and spatial planning documents
- ✓ **conducting cataloguing and research works** on seriously threatened monuments



Section for Documentation, Record and Registry of Immovable Monuments

- ✓ **conducting the National Monument Record** within the range of immovable monuments
- ✓ collecting copies of decisions, issued by the Voivodship Inspectors of Monuments, concerning the listing of particular objects into the **register of immovable monuments**
- ✓ **working out standards** of creating documentation and making them accessible to the public
- ✓ **creating databases** of immovable monuments



Section for Documentation, Record and Registry of Movable Monuments

- ✓ **conducting the National Monument Record** within the range of movable monuments
- ✓ collecting copies of decisions, issued by the Voivodship Inspectors of Monuments, concerning the listing of particular objects into the **register of immovable monuments**
- ✓ **working out standards** of creating documentation and rendering accessible to the public
- ✓ collecting information of museums
- ✓ editing the volume of „Muzealnictwo”

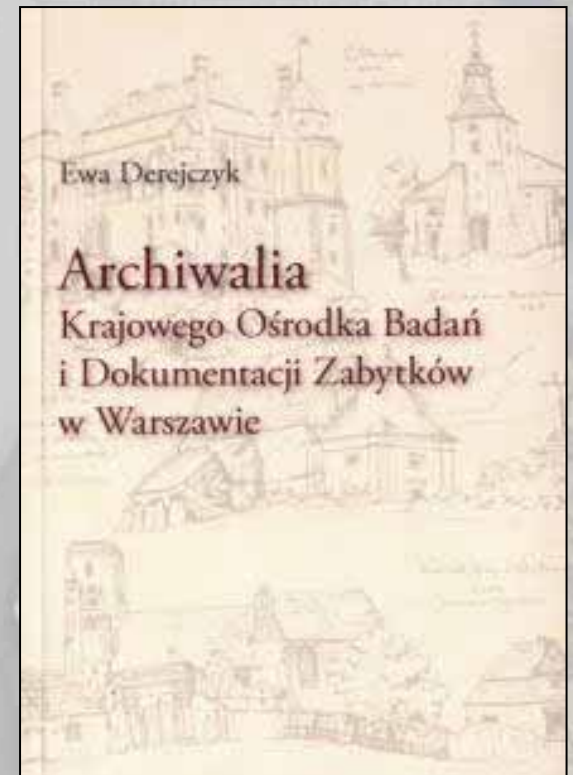

- ✓ administering the archival resources of the National Board and Regional Divisions



Section for Heritage Promotion

- ✓ **popularising the idea of heritage protection** in cooperation with institutions, local government units, conservatory services and non-government organisations in Poland and beyond its boundaries, including the coordination of European Heritage Days in Poland, (main theme of EHD 2007: „People of the Road. Travellers, Pilgrims, Wanderers”)
- ✓ **coordination** of editorial, exhibition and conference activities of the Board
- ✓ administering and updating Board's **web pages**
- ✓ **creating standards of communication** and principles of Board's visual policy, contact with media
- ✓ organising **internal communication of the National Board**, including the principles of information flow between the sections, communication with Regional Divisions, intranet etc.

- ✓ organising training courses on heritage protection for the Police, Border Guard, Customs Service, Forest Guard and institutions engaged in fighting the crime against heritage
- ✓ organising inner trainings for the employees of the Board and Regional Divisions
- ✓ **providing information** on accessible sources of financing within the sphere of heritage and monuments protection
- ✓ stimulating activities within the sphere of **museum education** in Poland with particular consideration of **best practices promotion**

- ✓ cooperation with other specialist libraries



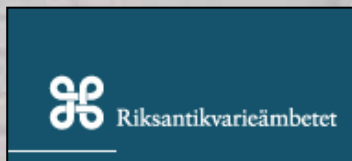

- ✓ coordinating actions connected with awarding prizes by Minister to the **finders of precious archaeological relics**, in accordance with standing regulations
- ✓ managing Priority 4 - Protection of Archaeological Monuments, of the **Minister's Operational Program „Cultural Heritage”**

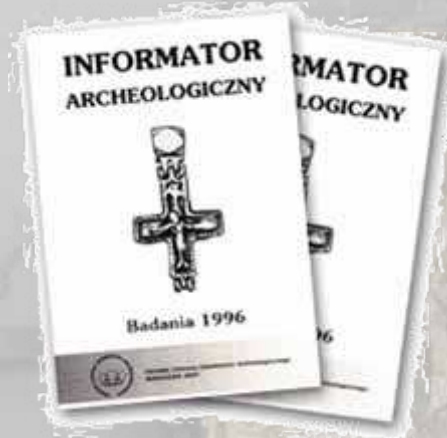
- ✓ participating, in cooperation with heritage protection services, in protection of archaeological sites against the **risk of destruction**

- ✓ **conducting the registry of archaeological heritage in Poland**, which is a part of National Monuments Registry and rendering the data accessible to the authorized persons
- ✓ editing the volume „Informator Archeologiczny”
- ✓ cooperation with Police, Border Guard, Customs Service, Forest Guard and State Fire Service within the **sphere of protection and evaluation of threats for archaeological heritage**, with particular consideration of illegal trade of archaeological relics

Administrative service of Regional Divisions → Coordination Team for Regional Divisions

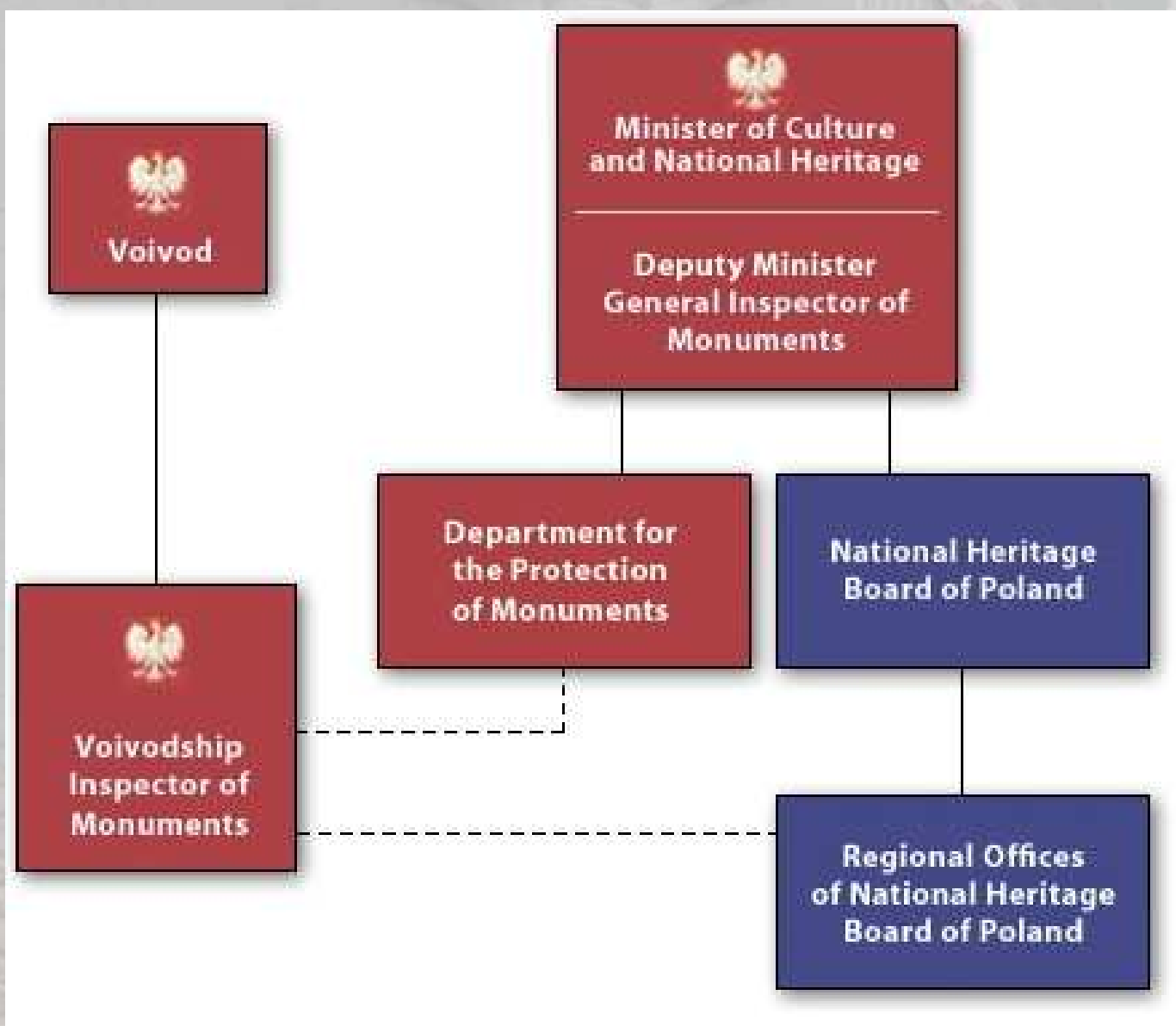


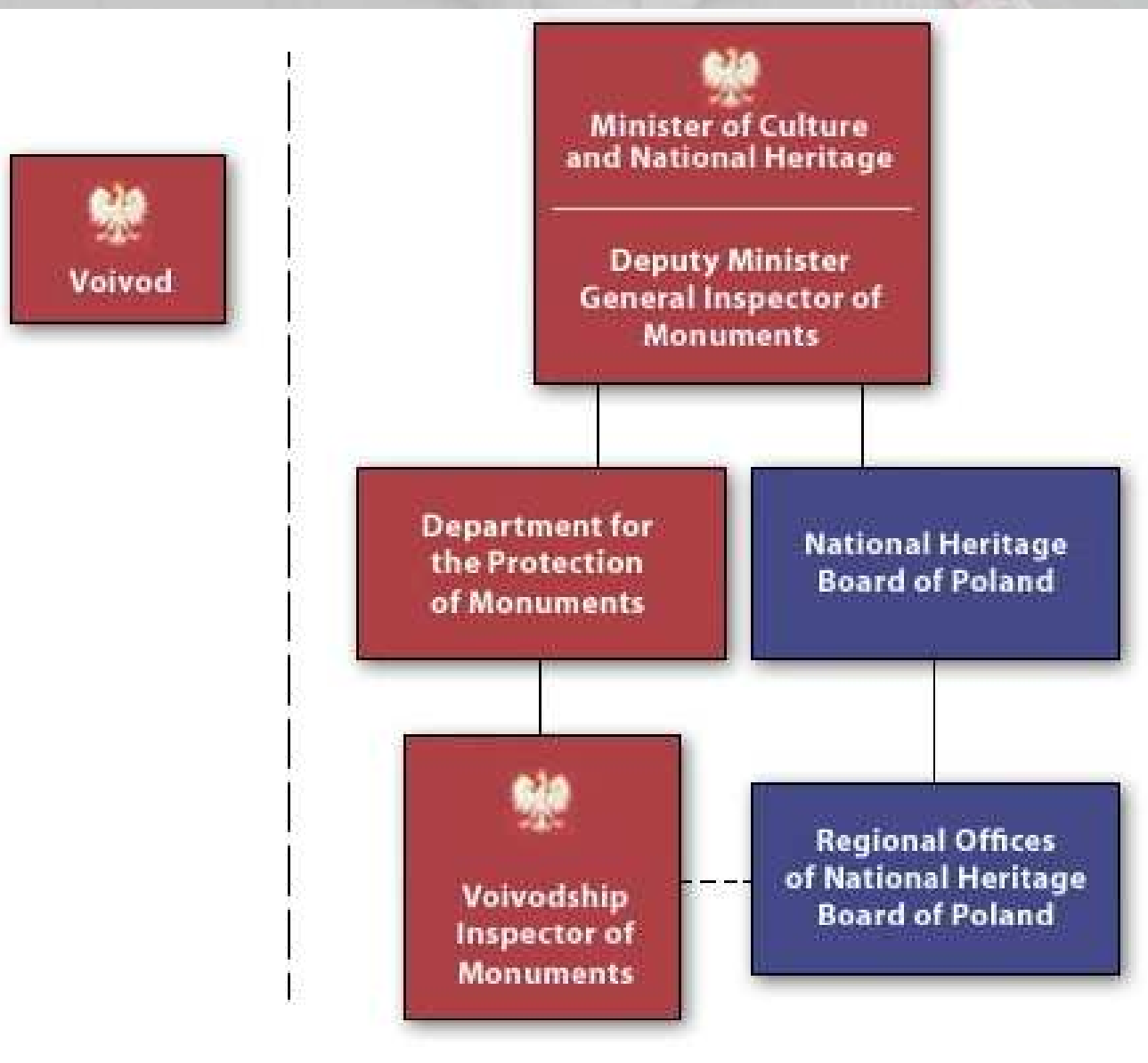
